McCool of said state and county considering the uncertainty of this life and the certainty of death and the uncertainty of the time do hereby make publish and declare this to be my last will and testament in manner and form as follows: Item First, My will is that after my death my body be decently buried without extravagance and that my just debts I may have against me as well as my funeral expenses be paid out of the means I may leave at my death, my executor hereinafter named to sell such property as he may deem best ~~fix~~ if need be to raise the money for the same. Item Second My will is that all the property I may leave at my death both real and personal shall be taken in possession by my Executor and that he shall also have the possession and control of all my children and shall raise them up on said property selling any or of what is necessary for the purpose at public or private sale as he may deem best for said children and if he can raise them up and educate them out of said means left by me and their own proper exertions and have any means or effects of my estate unexpended the same is to be equally divided among them all by sale or otherwise as my appear most equitable. Item Third I hereby nominate and appoint my brother, Richard V. Gray my sole Executor of this my last will and testament written on this and foregoing page in witness whereof I hereunto set my hand and seal signed, sealed and acknowledged in our presence 25th March, 1866.

IN MEMORIAM

James F. McCool died at his home in Kosciusko, Miss., on March 19, 1919. He was born in Lafayette County, Alabama, February 24, 1853, and left an orphan at the early age of nine years, his father, Lafayette McCool, a Confederate soldier, having died during the Civil War. By his application and energy, and without wealth or influence, he obtained a liberal education in the schools of Alabama and State Springs College, Mississippi, from which he was enabled to enter the University of Mississippi and graduated in the Law Department in 1879. He was admitted to the bar and located in Kosciusko, Mississippi, where he was practicing law at the time of his death.

He attained eminence not only as a lawyer, but as a statesman, and as a Judge under three successive administrations when the judges and chancellors were appointed by the Governor.

This, too, during a period of twelve years when personal politics was the issue in Mississippi, and by executives whose aspirations he had opposed for office. No greater tribute could be paid his manly qualities or honesty and integrity of character than these three successive appointments of him under such circumstances, as chancellor of his district.


He was a representative from Attala County in the State Legislature of 1882, 1884, 1896 and 1898, and speaker of the house of representatives during the session of 1896 and 1898.

In 1888 a delegate from the State at large to the National Democratic Convention that nominated Cleveland and Thurman; and in all these responsible positions served his people and state credibly. He was open and candid to bluntness, but loyal to friend and cause, as he saw the right. He was married to Mary (Niles) McCool, a daughter to Judge Jason Niles of Kosciusko, Miss., in December, A. D. 1880, who only survived him a few days.

He was elected Grand Master of Masons in 1896, but was seriously ill the better part of the year and the administrative duties of this exalted position were largely discharged by Brother L. F. Rainwater, the District Deputy Grand Master. He presided though at the State Annual Communication of the Grand Lodge, and in his address recommended that the Grand Lodge be permanently located, and ways and means provided for the erection of a suitable Masonic Temple. I recall an expression used by him in this connection that was characteristic of our brother, "that the Grand Lodge had been jumping around like a Jack Rabbit long enough and the time had come when it should permanently located."
